Agenda. - (a) Dr. Sovanjan Sarkar informed the DC that Ms. Debjani Das, Assistant Professor of History, VU has introduced Mr. Swarnam Bagaria, Ph.D. scholar of Johns Hopkins University, USA to him. Dr. Sarkar proposed that whether Mr. Bagaria can be invited to deliver a special lecture in the Department.

In this continuation Prof. K. Bose also proposed that whether Prof. Dr. Michael Hermanussen and Dr. Christiane Scheffler, both from Germany may be invited to deliver special invited lectures in the Department sometimes in November, 2018.
