Resolutions

- The Proceedings of the previous teacher-student committee-meeting held on 05.09.2017 were read and confirmed.
- The HOD placed in the meeting the letter from the Registrar, VU regarding "Furnishing the information regarding formation of the Adhoc Students' Council at Vidyasagar University." After due deliberation, the committee members prepared following panels of M.Sc. and M.Phil programmes based on academic performance.

- 3(A) (i) Repositioning and repairing of existing fans in all the class rooms
(ii) There are some windows in classrooms which need to be repaired and curtains need to be put.
(iii) Black Board of classes could be changed and white board may be placed in all classrooms.
(iv) Light in second semester classroom is not sufficient.
(v) ACs in the seminar hall are not working properly.
