<u>Resolution</u>: The Executive Council of Vidyasagar University noted the letter stating that the Midnapore Law College was established with the permission of the Government of West Bengal duly affiliated by Vidyasagar University and recognized by the Bar Council of India, New Delhi on self-financing basis from the academic session 2002-2003. The college has been registered u/s 2(f) and 12(B) of UGC Act, 1956. Midnapore Law College got permanent affiliation from Vidyasagar University in the year 2003. In this connection the Director has requested the University authority to re-consider the decision for de-affiliation of Midnapore Law College and also advise to refrain from de-affiliating of the said college. If they fail to get redressal of their grievances, they have no other alternative but to take shelter of the court of law.
